






OVERVIEW

Note:

The GPAT qualified candidates seeking admission in M. Pharm. program of the Institution are entitled for complete waiver in tuition fees (i.e. 100 % Scholarship), provided that their GPAT score validity has not expired in the Academic Year 2025-26. The maximum candidates who can avail the said benefit shall not be more than 50% of the total intake for that respective branch. These candidates on admission shall not be entitled for stipend.



ELIGIBILITY CRITERIA FOR ADMISSION TO PHARMACY PROGRAMS

(Note: The Candidate applying to any of the Undergraduate programs of the institution shall be 17 years as on 31 December of the year of admission and shall be medically fit to undergo the said programs. The candidate must fulfil the following eligibility criteria over and above the aforementioned condition.)

Diploma in Pharmacy (D. Pharm.)

A pass in 10+2 examination (science academic stream) with Physics, Chemistry and Biology or Mathematics.

Or

Any other qualification approved by the Pharmacy Council of India as equivalent to the above examination. **Course Duration:** 2 Years

B. Pharm

Candidate shall have passed 10+2 examination conducted by the respective State/Central Government authorities recognized as equivalent to 10+2 examination by the Association of Indian Universities (AIU) with English as one of the subjects and Physics, Chemistry, Mathematics (P.C.M) and or Biology (P.C.B / P.C.M.B.) as optional subjects individually. Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations. **Course Duration:** 4 Years

B. Pharm. (Lateral Entry, Diploma to Degree in Pharmacy)

A pass in D. Pharm. course from an Institution approved by the Pharmacy Council of India under section 12 of the Pharmacy Act.

Course Duration: 3 Years

Pharm. D.

A pass in any of the following examinations

(1) 10+2 examination with Physics and Chemistry as compulsory subjects along with one of the following subjects: Mathematics or Biology.

(2) A pass in D. Pharm course from an Institution approved by the Pharmacy Council of India under section 12 of the Pharmacy Act.

(3) Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations. Provided that a student should complete the age of 17 years on or before 31st December of the year of admission to the course.

Course Duration: 05 Years + 12 Months Internship



Pharm. D. (PB)

A pass in B. Pharm from an Institution approved by the Pharmacy Council of India under section 12 of the Pharmacy Act. **Course Duration:** 02 Years + 12 Months Internship

Master of Pharmacy (M. Pharm.) – All Branches

*A Pass in the following examinations

(1) B. Pharm Degree Examination of an Indian university established by law in India from an Institution approved by Pharmacy Council of India and has scored not less than 55 % of the maximum marks (aggregate of 4 years of B. Pharm.)

(2) Every student, selected for admission to post graduate Pharmacy program in any PCI approved Institution should have obtained registration with the State Pharmacy Council or should obtain the same within one month from the date of his/her admission, failing which the admission of the candidate shall be cancelled.

Note: It is mandatory to submit a migration Certificate obtained from the respective University where the candidate had passed his/her qualifying degree (B. Pharm.)

Course Duration: 2 Year

Post-graduate Diploma in Pharmaceutical Marketing & Management

- The candidate shall have passed B Pharm. / M Pharm. from an Institution approved by the Pharmacy Council of India under section 12 of the Pharmacy Act OR
- The candidate shall have B. Sc. / M. Sc. with a 2 years work experience in the pharmaceutical Industry in a sales / marketing profile.






ADMISSION CANCELLATION POLICY

2	90%	Less than 15 days before the formally- notified last date of admission
3	80%	15 days or less after the formally- notified last date of admission
4	50%	30 days or less, but more than 15 days, after formally- notified last date of admission
5	00% #	More than 30 days after formally- notified last date of admission

Note:

- *Caution money / Security deposit, which are not part of the fees chargeable, shall be refunded in full.
- In case of (1) in the table above, the Institution shall deduct an amount not more than 5% of the annual tuition fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
- Fees shall be refunded by the Institution to an eligible student within fifteen working days from the date of receiving a written application from him/her in this regard.
- In case of point (5#) in the table above, if the student leaves the course or in the event of cancellation of his / her admission, due to any reason whatsoever, any time after the 30 days of formally - notified last date of admission, the student is liable for payment of the fees for the remaining period of complete tenure of his/her program of study, to the Sumandeep Vidyapeeth Deemed to University, as the seat will remain vacant thereafter. In that event, Sumandeep Vidyapeeth has all the rights to recover the payment of the fees for the remaining period of complete tenure of his/her program of study, by redeeming unconditional bank guarantee / Un-dated cheques submitted by the student at the time of admission or through any other appropriate legal procedure against the student/parent/guardian for the recovery of entire outstanding amount against him/her.


